Thank you for registering your child to Cheder Chabad of Monsey. While the Cheder’s scholarship funds are limited, the Cheder realizes that not all families are able to pay full tuition.

Tuition assistance is granted current school year to families who qualify for tuition assistance based on guidelines and parameters created by the Cheder’s Board of Directors. All determinations are made by the Tuition Assistance Committee (TAC), based upon those guidelines and parameters.

Tuition assistance applications will only be considered if the Online Registration Form has already been completed and the required Registration Fees have been paid to the Cheder’s administration office.

If you wish to be considered for tuition assistance, please follow the steps below:

- 1 - Complete the Application for Tuition Assistance in full and return all required documentation to the Cheder via e-mail, regular mail or in person
- 2 - Wait for the TAC to review your application and receive notification via e-mail from the administration office if tuition assistance is available.
- 3 - Log into your account to accept the scholarship offer and make payment arrangements.
